Nomination for Secretary to Diocesan Convention

Dr. Norah T. Grimball, Trinity Cathedral, Columbia

Dr. Norah T. Grimball is a life-long Episcopalian and a member of Trinity Cathedral where she currently serves as Chair of the Eucharistic Ministers, Chair of the Finding God's Path Ministry, and a recovery coach in the Family Recovery and Support Ministry. Previous Cathedral service includes Junior and Senior Wardens, Vestry, Finance Committee, Diocesan Convention Delegate, Eucharistic Visitor, Worship Leader, Pastoral Care Team Chair and Covenant Group leader.

On the diocesan level, she serves as Secretary of DEC/Standing Committee, Chair of the Resolutions Committee, a member of the Commission on The Episcopal Church and the Anglican Communion, and has served previously as a Deputy to General Conventions 2015 and 2018, Chair of Commission on Ministry, Chair of the Bishop's Interview and Discernment Committee, Co-chair of the Commission on Ministry of the Baptized, and Communications Chair of the Bishop Search Committee. She is also a spiritual director.

Dr. Grimball has worked primarily in the field of adult education, including several years as Director of Education and Training for the Computer Services Division at the University of South Carolina. For 28 years she was employed by Teradata Corporation (formerly NCR) where she was a manager in the Training Division, responsible for development and delivery of training to a global audience as well as facilitation of crossfunctional teams, workshops, meetings and conference calls. She is a graduate of the University of South Carolina (B.A.), Ohio State University (M.S.), and Graduate Theological Foundation (D. Min.). She holds a certificate in Spiritual Guidance from the Institute for Spirituality at Palmetto Health and has also completed Sewanee's Education for Ministry program.

I would welcome the opportunity to serve as the Diocesan Treasurer. My church experience has prepared me through a combination of work at the parish, convocation, and diocesan levels; my education (particularly in finance) and professional service as a management professor at the University of South Carolina add relevant skills.

A Desire to Serve. I long have believed that EDUSC's future depends critically on its congregations' capacity to revitalize themselves rather than to accept gradual decline. Service on DEC and as its President and on the Commission on the Diocese and the SOM Committee has opened my eyes to the broader challenges and opportunities facing EDUSC.

Our Diocese must use its resources wisely to strengthen the parishes and missions in their efforts to carry out EDUSC's vision, while recognizing that the Diocese's financial resources flow primarily from its congregations. Stewardship of those resources includes improving our budgeting process through clearer and more complete communication, developing and adhering to financial policies and procedures that meet auditors' standards, and encouraging multi-year planning for financial needs.

I bring those perspectives as well as useful experience and professional skills plus a commitment to the imperatives of the Church and our Diocese. I feel called to offer my service to God through EDUSC and pray that it will be accepted.

Experience and Skills. In addition to EDUSC (see above), I have served parishes through vestry and church council leadership, involvement in adult and children's Christian Formation, and choir membership. Three rector's search committees (and seemingly countless faculty search committees) as well as deep involvement in strategic planning and budgeting in parochial, university, and business settings round out my experience. A Ph.D. in Management Policy and M.B.A. and undergraduate degrees in Finance have equipped me with concepts and skills that are helpful in such roles.



At that same General Convention, my sixth as a lay deputy from DUSC, I was appointed co-chair of the Legislative Committee on World Mission, where I learned of the work of TED across the world from

other deputies and representatives of many countries. I learned, sometimes painfully, of unspeakable horrors experienced by our own missionaries and survivors who testified before us: firsthand stories of starvation, human trafficking, religious persecution, violence. One of the results of the Committee's work was to reconstitute a Standing Commission on World Mission for TED, and organizational structure that had been disbanded by a GC resolution passed in 2015. Service on this legislative committee made me, once again, give thanks and reach a deeper understanding of Christ's command for us to "love our neighbors."

Closer to home, I continue to serve as a member of the Commission on The Episcopal Church for the DUSC, a member of the Worship Committee in my home parish of St. John's, Columbia, as well as the coordinator of Lay Eucharistic Ministries at St. John's. Having completed my term as Chair of the Board of Trustees for Kanuga Conferences, Inc., my husband Jim and I serve on the Kanuga Board of Visitors.

Ms. Whitney Evans



Whitney Evans was baptized at St. Thaddeus, Aiken, and grew up a communicant of St. Christopher's, Spartanburg. While at Duke University, she transferred her letter to St. Philip's, Durham. She graduated from Duke in 2004 and moved to Columbia, where she was a member at Trinity Cathedral until joining St. Timothy's in 2018. Mary Anne is married to Ron Park, and they have one son, David Sinclair Park. Both are active members of Saint Bartholomew's.


Mary Anne is a life-long, active member of Saint Bartholomew's

Recommendation from the Committee on Resolutions

A Resolution entitled: Supporting the Youngest Among Us

Committee on Resolutions Recommendation: Reject this resolution.

First, we are concerned by the judgmental and negative presumptions about pregnant women (and pregnant children) in this proposed resolution indicated in the following phrases [emphasis is by the Resolution Committee]:

- "whereas adoption is the kind, loving choice for everyone involved in an unwanted pregnancy"
- "to support pregnant mothers who **do not wish to care for** their unborn children"

Also, these presumptions are not in keeping with the position established by TEC, which is expressed as follows:

From the TEC website: "In a series of statements over the past decades, the Church has declared that 'we emphatically oppose abortion as a means of birth control, family planning, sex selection, or any reason of mere convenience.' At the same time, since 1967, The Episcopal Church has maintained its "unequivocal opposition to any legislation on the part of the national or state governments which would abridge or deny the right of individuals to reach informed decisions [about the termination of pregnancy] and to act upon them."

Second, we are concerned that funding for this resolution is based on the complete defunding of projects we have supported for many years through the 0.7% Sustainable Development Funds. Supporting this resolution would be an outright rejection of mission projects we have shared with people with whom we have developed relationships over many years in Haiti and Ecuador.

Third, we are concerned that changes to the SOM which so adversely impact historic missions of our diocese are more appropriately made through the SOM process so the appropriate Commission can evaluate all requests at once and determine priorities as appropriate to diocesan goals of making, equipping and sending mature disciples of Christ.

Finally, we believe it is inappropriate to direct diocesan funds to un-specified "non-governmental organizations that offer adoptive services to pregnant women" because some of these organizations in our state withhold services based on prejudicial view about adoptive parents that The Episcopal Church finds completely unacceptable.

A Resolution entitled: Feast of William Alexander Guerry

Committee on Resolutions Recommendation: Adopt with friendly amendment

Change the date from the third Sunday in June to June 9 which is the date of Guerry's death. Other than for special days (Pentecost, Christmas, e.g.) the Sunday Propers can be replaced only under extraordinary circumstances and with the approval of the Bishop.

Whereas:

As the pinnacle of creation, God created human beings in His image to enjoy Him forever, and at our baptisms God adopts us into Christ's family as his brothers and sisters;

and whereas the National Council for Adoption reports that in 2014 there were 18,329 domestic adoptions in relation to 1.1 million unwanted pregnancies;

and whereas U.S. adoption providers estimate there are over 1 million couples currently waiting to adopt in the United States;

and whereas adoption is the kind, loving choice for everyone involved in an unwanted pregnancy;

Be it Resolved:

That this Diocese affirms and offers God's love for each human life by committing, beginning in 2021, to support pregnant mothers who do not wish to care for their unborn children by providing financial support to non-governmental organizations that offer services to pregnant women that facilitate the adoption of their babies.

The amount of the financial support committed will be at least 0.7% of EDUSC's projected annual income. The funding for this support will come from eliminating from the 2021 and all future diocesan Statement of Missions the MDG funding directed in 2005 under the standing resolution adopted by 83rd Convention of the Diocese of Upper South Carolina and reported by the Commission on Mission in the EDUSC Statement of Mission and applying such funding to this support.

Such financial support will be provided annually and will continue until either 2030 or until terminated by resolution of a future diocesan convention, whichever comes first.

Further, this Diocese encourages the Commission on Mission, as part of the Statement of Mission request process, to identify the non-governmental organizations that offer adoptive services to pregnant women in South Carolina to whom support will be distributed, and to report annually through its Statement of Mission request submission the amount of such aid and the organization(s) to receive the distribution of such aid.

Standing Resolution: Feast of William Alexander Guerry

Whereas

William Alexander Guerry, native of South Carolina, was born in 1861, served as the bishop of the Diocese of South Carolina from 1907 to the time of his death in 1928. He had an illustrious career as a parish priest and bishop and as Chaplain and Professor of Homiletics and Pastoral Theology at the University of the South.

Whereas in 1909, the second year of his episcopate, Bishop Guerry, addressing a meeting of provincial church leaders in Birmingham, Alabama, explained his belief about the breadth and depth of the Christian community: "We should strive for unity, not uniformity. Uniformity is mechanical, barren, unfruitful, and unprofitable. Unity is organic, living, and capable of endless growth. If we are to be truly catholic, as Christ himself is catholic, then we must have a church broad enough to embrace within the communion every living human soul."

Whereas Bishop Guerry's theology of the broadness of the church led him to propose, in 1914, the election of a black suffragan bishop for South Carolina to be responsible for the ministry to black Episcopalians, and to ensure that all people, regardless of race, were part of the community of Christ in the diocese. The alternative, which unfortunately prevailed, was to separate the African American community into a "Missionary Church for Negroes," an arrangement that continued until the mid-20th century when that segment of the Christian community was finally given an equal place in the community.

Whereas the bishop's life on earth ended on June 9, 1928, five days after he was shot in his office at St. Philip's Church, Charleston, by a priest who had attacked the bishop's position on advancing racial equality in South Carolina, and especially on his proposal to install a black suffragan bishop in the diocese. The priest who shot the bishop had written that the bishop, given his way, would root out the principle of white supremacy in the south. So, overtaken by hatred, he fired the shot that killed the bishop and then turned the gun on himself, taking his own life;

Whereas, in its call to revise Lesser Feasts and Fasts, "General Convention emphasized the importance of the local recognition of sanctity. As we look across the Church's broad history, this is, in fact, the predominant level on which sanctity has been identified" (Great Cloud of Witnesses, page x). Local feasts are encouraged under Days of Special Observances in The Book of Common Prayer (pages 17-18); and

Whereas, the Episcopal Church in South Carolina recognizes the third Sunday of June each year as the Feast of William Alexander Guerry, and has developed the associated readings and collect; now, therefore, be it

Resolved,

- 1. that the 97th Convention of the Episcopal Diocese of Upper South Carolina adopt <u>June 9th of each year</u> the third Sunday of June each year as the Feast of William Alexander Guerry, Bishop, Reformer, and Martyr;
- 2. that the readings assigned for this day shall be:

Isaiah 61:1-4 Psalm 116:1-8 Acts 7:54-60 Luke 12:2-8; and

3. that the collect for this day shall be:

God of truth and sacrifice, we give thanks for your servant William Alexander Guerry, who, like the church's first martyr, gave witness to your liberating gospel and echoed Christ's healing words of forgiveness. May we also seek your truth as we offer ourselves in obedience to the same. All this we pray through him who is forever the bishop and reformer of our souls, Jesus Christ our Savior. Amen.

Title V, Section 1(c) Canons of the Diocese of Upper South Carolina

Detailed Rationale for Proposed Change:

This amendment is offered in response to concerns that it is not clear on the face of Title V, Section 1(c) that motions can be made on the floor of Convention to amend any timely and properly submitted motion to amend the Statement of Mission. This amendment also clarifies that the Statement of Mission Committee is not subject to the requirement that any motion to amend the Statement of Mission be made five business days prior to Convention.

Resolution:

RESOLVED, that Title V, Canon 1, Section 1(c) of the Canons of the Episcopal Diocese of Upper South Carolina be, and hereby is, amended to add the underlined text below:

(c) Other than a motion by the Statement of Mission Committee, any motion to amend the Statement of Mission that is to be made on the floor of Convention must be in writing and must be received by the Secretary to Convention not later than five business days prior to Convention. Any such notice to the Secretary of Convention of a proposed motion to amend the Statement of Mission that would increase the funding for any line item, or add any new line item, shall state the source of such additional funding or shall propose a decrease of an amount equal to the proposed increase or new line item from another line item or items within the Statement of Mission. This provision shall not preclude any motion made on the floor of Convention to amend any motion to amend the Statement of Mission that has been properly submitted pursuant to the foregoing procedure. Any such motion to amend a motion to amend the Statement of Mission that would increase the funding for any line item, or add any new line item, shall also state the source of such additional funding or shall propose a decrease of an amount equal to the proposed increase or new line item from another line item or items within the Statement of Mission.

And further, RESOLVED, that Title V, Canon 1, Section 1(c) shall remain otherwise unchanged.



Resolutions Referred to Dioceses from the 79th General Convention of The Episcopal Church Austin, Texas

A Summary

The 79th General Convention proposed several changes to the Constitution of The Episcopal Church (TEC). In accordance with Article XII of the TEC Constitution, it is the responsibility of each Diocese to make known such proposed alterations to its Convention prior to the 80th General Convention in 2021, and to certify that such action has been taken.

The text of each proposed amendment is included in the Convention Handbook. The following is a summary of the amendments, many of which are technical in nature:

A063: amends Constitution Article X to permit a General Convention to approve alternate and additional liturgies as a supplement to the Book of Common Prayer.

A089: amends Constitution Articles VI and VII to ensure consistency in the Constitution and Canons with respect to referring to a Church denomination being in "full communion" with The Episcopal Church.

A122: Amends Article IX of the Constitution to delete the word "removal" in paragraph 6. In 1994, the General Convention amended Title IV of the Canons (the disciplinary canon) by eliminating "removal" as a sentence and adding Admonition as a sentence. However, the reference to "removal" in Article IX of the Constitution was not changed.

A150: Amends Article I.2 of the Constitution to make consistent the use of the term "Bishop Suffragan" throughout the Constitution and Canons. The last sentence clarifies the meaning of a bishop "exercising" or "having" jurisdiction, including jurisdiction over areas that are not dioceses such as Navajoland, the Convocation of Episcopal Churches in Europe (over which the Presiding Bishop exercises jurisdiction), and Guam (over which the Presiding Bishop exercises jurisdiction).

A151: Amends Article II.4-8 of the Constitution as follows:

- Section 4: To make the titles of bishops consistent throughout the Constitution and Canons.
- The amendment to Section 5 clarifies that a Bishop Suffragan may be placed in charge of a diocese and exercise jurisdiction as the Bishop Diocesan Pro Tempore until a successor is consecrated if the Bishop Diocesan dies, resigns or is removed from office or until the Bishop Diocesan returns to office if the absence is temporary.
- The amendment to Section 8 clarifies that a total of five years of combined service, served consecutively, as Bishop Coadjutor and then Bishop Diocesan is required before the bishop may be elected elsewhere.
- A152: Amends Article III of the Constitution to correct a typographical error.
- A153: Amends Article IV of the Constitution to make the titles of bishops consistent throughout the Constitution and Canons.
- A176: Amends Article V of the Constitution with respect to procedures required to form a new Diocese.
- A183: Amends Article IX to provide for the possible creation of a provincial, church-wide, or other way of providing for the discipline of Priests and Deacons, as an alternative to each Diocese maintaining its own separate disciplinary structure.



RESOLUTIONS REFFERED TO DIOCESES FROM THE 79TH GENERAL CONVENTION

Proposed Constitutional Amendments, First Reading

The following Constitutional amendments shall be read by the Secretary of the Diocesan Convention preceding the final vote at the 80th General Convention in 2021, such reading to be certified by the Diocesan Convention with the Secretary of the General Convention.

A063: Amend Article X of the Constitution of the Episcopal Church (First Reading)

Resolved, That the 79th General Convention of The Episcopal Church amend Article X of the Constitution of the Episcopal Church as follows

ARTICLE X

The Book of Common Prayer, as now established or hereafter amended by the authority of this Church, shall be in use in all the Dioceses of this Church. No alteration thereof or addition thereto shall be made unless the same shall be first proposed in one regular meeting of the General Convention and by a resolve thereof be sent within six months to the Secretary of the Convention of every Diocese, to be made known to the Diocesan Convention at its next meeting, and be adopted by the General Convention at its next succeeding regular meeting by a majority of all Bishops, excluding retired Bishops not present, of the whole number of Bishops entitled to vote in the House of Bishops, and by a vote by orders in the House of Deputies in accordance with Article I, Sec. 5, except that concurrence by the orders shall require the affirmative vote in each order by a majority of the Dioceses entitled to representation in the House of Deputies. But notwithstanding anything herein above contained, the General Convention may at any one meeting, by a majority of the whole number of the Bishops entitled to vote in the House of Bishops, and by a majority of the Clerical and Lay Deputies of all the Dioceses entitled to representation in the House of Deputies, voting by orders as previously set forth in this Article:

- (a) Amend the Table of Lessons and all Tables and Rubrics relating to the Psalms.
- (b) Authorize for trial use throughout this Church, as an alternative at any time or times to the established Book of Common Prayer or to any section or Office thereof, a proposed revision of the whole Book or of any portion thereof, duly undertaken by the General Convention.
- (c) Authorize for use throughout this Church, as provided by Canon, alternative and additional liturgies to supplement those provided in the Book of Common Prayer.

And Provided that nothing in this Article shall be construed as restricting the authority of the Bishops of this Church to take such order as may be permitted by the Rubrics of the Book of Common Prayer or by the Canons of the General Convention for the use of special forms of worship.

Ao89: Amend Articles VI and VIII Regarding Full Communion

Resolved, That the 79th General Convention amend Articles VI and VIII to read as follows:

ARTICLE VI

Sec. 1. The House of Bishops may establish a Mission in any area not included within the boundaries of any Diocese of this Church or of any Church in *full* communion with this Church, and elect or appoint a Bishop therefor.

ARTICLE VIII

No person shall be ordered Priest or Deacon to minister in this Church until the person shall have been examined by the Bishop and two (2) Priests and shall have exhibited such testimonials and other requisites as the Canons in that case provided may direct. No person shall be ordained and consecrated Bishop, or ordered Priest or Deacon to minister in this Church, unless at the time, in the presence of the ordaining Bishop or Bishops, the person shall subscribe and make the following declaration:

I do believe the Holy Scriptures of the Old and New Testaments to be the Word of God, and to contain all things necessary to salvation; and I do solemnly engage to conform to the Doctrine, Discipline, and Worship of the Episcopal Church.

Provided, however, that any person consecrated a Bishop to minister in any Diocese of an autonomous Church or Province of a Church in *full* communion with this Church may, instead of the foregoing declaration, make the promises of Conformity required by the Church in which the Bishop is to minister.

If any Bishop ordains a Priest or Deacon to minister elsewhere than in this Church, or confers ordination as Priest or Deacon upon a Christian minister who has not received Episcopal Ordination, the Bishop shall do so only in accordance with such provisions as shall be set forth in the Canons of this Church.

No person ordained by a foreign Bishop, or by a Bishop not in *full* communion with this Church, shall be permitted to officiate as a Minister of this Church until the person shall have complied with the Canon or Canons in that case provided and also shall have subscribed the aforesaid declaration.

A Bishop may permit an ordained minister in good standing in a church with which this Church is in *full* communion as specified by the Canons who has made the foregoing declaration, or a minister ordained in the Evangelical Lutheran Church in America or its predecessor bodies who has made the promise of conformity required by that Church in place of the foregoing declaration to officiate on a temporary basis as an ordained minister of this church. No minister of such a Church ordained by other than a Bishop, apart from any such ministers designated as part of the Covenant or Instrument by which full communion was established, shall be eligible to officiate under this Article.

A122: Amend Article IX to Change Removal to Admonition

Resolved, That the Article IX of the Constitution be amended as follows:

ARTICLE IX

The General Convention may, by Canon, establish one or more Courts for the Trial of Bishops.

Presbyters and Deacons canonically resident in a Diocese shall be tried by a Court instituted by the Convention thereof; Presbyters and Deacons canonically resident in a Missionary Diocese shall be tried according to Canons adopted by the Bishop and Convocation thereof, with the approval of the House of Bishops; provided that the General Convention in each case may prescribe by Canon for a change of venue.

The General Convention, in like manner, may establish or may provide for the establishment of Courts of Review of the determination of diocesan or other trial Courts

The Court for the review of the determination of the trial Court, on the trial of a Bishop, shall be composed of Bishops only.

The General Convention, in like manner, may establish an ultimate Court of Appeal, solely for the review of the determination of any Court of Review on questions of Doctrine, Faith, or Worship. None but a Bishop shall pronounce sentence of *admonition*, or suspension, or removal or deposition from the Ministry, on any Bishop, Presbyter, or Deacon; and none but a Bishop shall admonish any Bishop, Presbyter, or Deacon.

A sentence of suspension shall specify on what terms or conditions and at what time the suspension shall cease. A sentence of suspension may be remitted in such manner as may be provided by Canon.

A150: Amend Article 1.2 of the Constitution

Resolved, That Article I, Section 2 of the Constitution is hereby amended to read as follows:

Article I

Sec. 2. Each Bishop of this Church having jurisdiction, every Bishop Coadjutor, every Bishop Suffragan Bishop, every Assistant Bishop, and every Bishop who by reason of advanced age or bodily infirmity, or who, under an election to an office created by the General Convention, or for reasons of mission strategy determined by action of the General Convention or the House of Bishops, has resigned a jurisdiction, shall have a seat and a vote in the House of Bishops. A majority of all Bishops entitled to vote, exclusive of Bishops who have resigned their jurisdiction or positions, shall be necessary to constitute a quorum for the transaction of business. Bishops who exercise or have jurisdiction are those who exercise ecclesiastical authority in a diocese or other jurisdiction of this Church.

A151: Amend Article I.4-8 of the Constitution

Resolved, That Article II.4-8 of the Constitution is hereby amended to read as follows:

ARTICLE II

Sec. 4. It shall be lawful for a Diocese, at the request of the Bishop of that Diocese, to elect not more than two Suffragan Bishops Suffragan, without right of succession, and with seat and vote in the House of Bishops. A Suffragan Bishop Suffragan shall be consecrated and hold office under such conditions and limitations other than those provided in this Article as may be provided by Canons of the General Convention. A Suffragan Bishop Suffragan shall be eligible for election as Bishop Diocesan or Bishop Coadjutor of a Diocese, or as a Bishop Suffragan in another Diocese.

Sec. 5. It shall be lawful for a Diocese to prescribe by the Constitution and Canons of such Diocese that upon the death, removal or deposition of the Bishop or if the Bishop resigns, or is removed from office pursuant to Canon III.12.12(7), a Suffragan Bishop Suffragan of that

Diocese may be placed in charge of such Diocese and become temporarily the Ecclesiastical Authority thereof serving as the Bishop Diocesan Pro Tempore-until such time as a new Bishop shall be chosen and consecrated; or that during the disability or absence of the Bishop, a Bishop Suffragan of that Diocese may be placed in charge of such diocese and become temporarily the Ecclesiastical Authority thereof serving as the Bishop Diocesan Pro Tempore of the Diocese.

Sec. 6. A Bishop may not resign jurisdiction without the consent of the House of Bishops.

Sec. 7. It shall be lawful for the House of Bishops to elect a Suffragan-Bishop Suffragan who, under the direction of the Presiding Bishop, shall be in charge of the work of those chaplains in the Armed Forces of the United States, Veterans' Administration Medical Centers, and Federal Correctional Institutions who are ordained Ministers of this Church. The Suffragan Bishop Suffragan so elected shall be consecrated and hold office under such conditions and limitations other than those provided in this Article as may be provided by Canons of the General Convention. The Suffragan-Bishop Suffragan shall be eligible for election as Bishop Diocesan, orBishop Coadjutor or Suffragan-Bishop Suffragan of a Diocese.

Sec. 8. A Bishop Diocesan or Coadjutor who has for at least five years next preceding exercised jurisdiction as the Ordinary, served as the Bishop Diocesan nor as the Bishop Coadjutor, of a Diocese for any period of time, may be elected as Bishop Diocesan, Bishop Coadjutor, or Suffragan—Bishop Suffragan of another Diocese only if five or more years have passed since the Bishop first served as Bishop Diocesan or Bishop Coadjutor of the Diocese in which the Bishop is currently or last served as Bishop Diocesan or Bishop Coadjutor. Before acceptance of such election a resignation of jurisdiction in the Diocese in which the Bishop is then serving, conditioned on the required consents of the Bishops and Standing Committees of the Church to such election, shall be submitted to the House of Bishops, and also, if the Bishop be a Bishop Coadjutor, a renunciation of the right of succession. Such resignation, and renunciation of the right of succession in the case of a Bishop Coadjutor, shall require the consent of the House of Bishops.

A152: Amend Article III of the Constitution

Resolved, That Article III of the Constitution is hereby amended to read as follows:

ARTICLE III

Bishops may be consecrated for foreign lands upon due application therefrom, with the approbation of a majority of the Bishops of this Church entitled to vote in the House of Bishops, certified to the Presiding Bishop; under such conditions as may be prescribed by Canons of the General Convention. Bishops so consecrated shall not be eligible to the office of Diocesan or of Bishop Coadjutor of any Diocese in the United States or be entitled to vote

in the House of Bishops, nor shall they perform any act of the episcopal office in any Diocese or Missionary Diocese of this Church, unless requested so to do by the Ecclesiastical Authority thereof. If a Bishop so consecrated shall be subsequently duly elected as a Bishop of a Missionary Diocese of this Church, such election shall then confer all the rights and privileges given in the Canon Canons to such Bishops.

A153: Amend Article IV of the Constitution

Resolved, That Article IV of the Constitution is hereby amended to read as follows:

ARTICLE IV

In every Diocese a Standing Committee shall be elected by the Convention thereof, except that provision for filling vacancies between meetings of the Convention may be prescribed by the Canons of the respective Dioceses. When there is a Bishop in charge of the Diocese, the Standing Committee shall be the Bishop's Council of Advice. If there be no Bishop or Bishop Coadjutor or Bishop Suffragan Bishop canonically authorized to act, the Standing Committee shall be the Ecclesiastical Authority of the Diocese for all purposes declared by the General Convention. The rights and duties of the Standing Committee, except as provided in the Constitution and Canons of the General Convention, may be prescribed by the Canons of the respective Dioceses.

A176: Amend Article V – Second Reading (Note: this is actually a first reading, because there was a floor amendment in 2018 and therefore must be read again in 2021)

Resolved, That Article V, Section 1 is amended as follows:

Sec. 1 A new Diocese may be formed, with the consent of the General Convention and under such conditions as the General Convention shall prescribe by General Canon or Canons, (1) by the division of an existing Diocese; (2) by the junction of two or more Dioceses or of parts of two or more Dioceses; or (3) by the erection into a Diocese of an unorganized area evangelized as provided in Article VI. The proceedings shall originate in a Convocation of the Clergy and Laity of the unorganized area called by the Ecclesiastical Authority Bishop for that purpose; or, with the approval of the Ecclesiastical Authority, in the Convention of the Diocese to be divided; or (when it is proposed to form a new Diocese by the junction of two or more existing Dioceses or of parts of two or more Dioceses) by mutual agreement of the Conventions of the Dioceses concerned, with the approval of the Ecclesiastical Authority of each Diocese. After consent of the General Convention, when a certified copy of the duly adopted Constitution of the new Diocese, including an unqualified accession to the Constitution and Canons of this Church, shall have been filed with the Secretary of the

General Convention and approved by the Executive Council of this Church, such new Diocese shall thereupon be in union with the General Convention.

A183: Amend Article IX - First Reading

Resolved, That the Constitution Article IX be amended to read as follows:

Article IX

The General Convention may, by Canon, establish one or more Courts for the Trial of Bishops.

Presbyters and Deacons canonically resident in a Diocese shall be tried by a Court instituted by the *General* Convention by Canon. thereof; Presbyters and Deacons canonically resident in a Missionary Diocese shall be tried according to Canons adopted by the Bishop and Convocation thereof, with the approval of the House of Bishops; provided that the General Convention in each case may prescribe by Canon for a change of venue.
